- 1. August 31, 2020 Minutes: Sierra made, Verena seconded, and the Committee unanimously approved a motion to adopt the August 31, 2020 minutes.

  - State funding for second segment of rail trail received. Second segment is Beach Bluff to Bradley. Committee is concerned that the \$150k is only getting a small stretch of the rail trail done.
