## No Resident Comment

### Selectmen Spellios

Selectmen Spellios spoke on the passing of Susan Balleza a resident of Swampscott and remarkable woman. She is remembered for so much, but in particular the garden at the monument. We thank her for all she has done for the Town. The Town will pay tribute to her in the near future. A moment of silence was held at the meeting on Ms. Balleza's behalf.

Selectmen Hause spoke about all impactful things we can now see such as the new lights, flowers, turf fields, beach improvements, waterfront master plans. The Fish House is iconic and oldest Fish House dating to 1896. It is in the historic registry. Saying it is falling to disrepair is an understatement.

Selectmen Hause made two important announcements.

First three important improvements- will be made to the Fish House. The roof will be replaced, the top of the building will be restored, and the trim and siding will be replaced. The Town is working with Historic District Committee and receiving funding from FEMA from the 2018 storm.

An amazing idea for beach stickers came out of the Idea Exchange. We will use in in lieu of the current beach sticker a rendering that was painted by Ms. Harris the Middle School Art Teacher. For her donated artwork for the new beach sticker, Ms. Harris received the first sticker and was thanked for her help in making this small idea a reality.

Notecards have also been created and 100% of the profit will go to the renovation of the Fish House. These cards will be available on the Town Website.

*Ms.* Harris spoke about the rich history of Swampscott and that now art is being included and she is thrilled to be part of it.

Selectmen Hause honored Toni Bandrowicz for being named the 2019 Conservation Commissioner of the Year. Toni volunteers so much time and has passion and diligence. She takes initiative in all her work with ERAC, Conservation Commission, Swampscott Conservancy, and Open Space Committee.

Selectmen Hause presented Toni with a proclamation which he read out loud.

# Discussion on Proposed Amendment to Zoning Bylaw regarding resiliency by Planning Board & Conservation Commission- Angela Ippolito & Toni Bandrowicz gave a Power point presentation.

The presentation given was on amendments to the zoning bylaw and the purpose is to incorporate up to date language to update existing zoning bylaw procedures.

The amendment was developed through a Coastal Zone Management grant, local funding and intown support. The town commission Kleinfelder prepared a coastal climate change study. The study recommended modifications to the existing zoning by law. This update will advance the town's goal of adapting to coastal climate change and impacts per the master plan. The recommended changes will strengthen building codes and zoning.

Angela Ippolito reviewed the proposed by law changes with the BOS.

Selectmen Spellios recommended the language 2.3.6.5- to be more specific and Angela Ippolito agreed to those changes.

Changes will be sent to Town Counsel and revised language will be sent back by the end of the week.

Toni B. spoke about Resiliency and tapping into government grants.

# Open Space and Recreation Plan Committee to discuss initiatives and current projects- Tania Lillak gave a Power Point Presentation.

This committee was formed from the Open Space and Recreation Plan. With this committee you can apply for many grants. In 2013 new plan came about-first plan was in 1983-2013 renewed commitment to the town.

There are 6 main goals:

Maintain open spaces and recreation facilities

Improve public access and awareness

Expand and improve open spaces and recreation facilities

Preserve the scenic character of the town

Strengthen environmental protection

Establish a green corridor network

The Main Initiative

*Economic Importance- benefits recreation sports/ strengthen environment, beauty, exercise/ health, social, emotional spiritual mental productivity* 

Open space is just not nice to have but viable

Development fails to decrease the tax rate

Commercial taxes not necessarily the answer

*Open spaces increase property values* 

Trees provide economic benefit

Environmental stability reduces costs

OSRP Goals for More open- acquire conservation restriction to protect open space and in perpetuity-

Reviewed the goals for more open space- 6 in total

Future Projects- plan will be up for renewal next year- ideas so far- illumination in open spaceseducation in schools- email addresses for trees- HS student to join our committee each year-

iNaturalist plants and wildlife identification-

Angela Ippolito chair of the Planning Board- talked about the Open Space Recreation Committee and how it came about and how great the committee is, outstanding they are to work with and there ability to do an amazing job on continuing to move forward.

Selectmen Dreeben- spoke about her concern about removal of trees on Town property and not having them replaced.

Selectmen thanked the committee for all their hard work.

*Idea Exchange – biggest volume of ideas was from Open Space and the BOS will be involving this committee along with others on exploring the ideas.* 

4/24/19 The Harbor Advisory will be talking on the draft Harbor Plan. The Town Administrator has been working hard and the Harbor Plan will provoke the dialogue along with state bond bills that will allow us to do some big things on the waterfront.

A concern was raised to make sure committees are more and more included in the budget process The BOS want to make sure as you are looking at ideas- be the feeder and tell the BOS what resources you need.

Discussion of Railroad Depot Building- Thanks to the TA and Marzi Galazka for facilitating a meeting with MBTA to discuss the desire to revive it. The town should seek to revive the first agreement to purchase this property from the MBTA and the BOS are all in favor. Another copy of the budget was distributed to the BOS.
