NEW AND OLD BUSINESS

Sean Fitzgerald gave a LICENSE RENEWAL PRESENTATION for 2019

Provided a breakdown of the license process and the timeline. Oct. establishments received a letter on renewal of license. The police dpt, building dpt and town hall are involved in this process. Letters due back Nov. and tonight we are reviewing those licenses for approval.
