JANUARY 19, 2017 MEETING MINUTES

B Franklin opened the meeting of the Historic District Commission at 7:30 pm, on January 19th, 2017.

APPROVAL OF THE PREVIOUS MINUTES

No prior minutes available.

CERTIFICATES

17HDC-02 (151 REDINGTON STREET) – request to replace windows on front and both sides of home (excluding front porch and basement). Applicant: JEFFREY P. KITTREDGE. Owner: AMY COUTURE-RIZZO. Parcel ID: 4-118. Continued from Jan 9 meeting

Applicant Jeffrey Kittredge present.

 B. Franklin updated S. Belkin on the prior proceedings and concerns about replacing windows that may be repaired.

Kittredge:

- House dates from roughly 1906
- 10 windows proposed replacement 1 is a vinyl window (ground floor to left of porch, which he indicates is not badly deteriorated)
- Original primary reason for the project was to remove lead from house (this is a to-the-studs renovation throughout the house).
- Presents set of photographs to demonstrate one vinyl, and damage to other windows. Indicates one window is missing a sash.
- Tracks between the two sashes (parting bead) some of these are broken. One is missing.
- Exterior trim is rotten, but believes this could be replaced with certificate of non-applicability
- Wants to replace all windows with Anderson 400 series new construction
- Demolition crew threw away the weights for the windows.
- Wood is "mostly there."
- \$10,500 to restore the windows with the full restoration including lead abatement (\$7,000 for a lower level); Plus \$225 to \$250 per storm window.
- Anderson 400 is about \$600 per window. (Total \$6,000) + labor costs (\$175 per window)
- Have other homeowners applied for replacement of historic windows? -- Committee answers yes, most applications have been denied.
- Expresses that additional outreach to educate new residents would be helpful.

R. Smith:

- Can see there is some work that needs to be done on the paint.
- Speculates that some glazing issues
- Parting beads are fairly easy to repair mostly stock in lumberyards.
- One over One sash is not unusual for this era

S. Belkin:

Is this a window style 1/1 that is typical for this era? (Yes, per R. Smith)

A. Steingeiser:

- Less of a issue replacing current vinyl with new vinyl, especially as it is next to two recently approved vinyl windows (from the 17HDC-01 application on the same property, approved Jan. 9).
- Windows are not in as poor repair as others in district, including own home. (B. Franklin makes the same observation)
- Committee should work with Peter Kane to try to improve outreach to new homeowners.

- The lead issue is not an issue within our purview
- Windows appear to be in generally good condition with exception of minor damage and paint issues.
- Cost difference is not huge, once \$6,000 cost of replacements and labor is added up (\$7,750, compared to roughly \$9,400 excluding the lead abatement issue)
- View is the additional cost of lead abatement is not before the committee.
- Agree with A. Steingeiser and applicant that additional outreach would be good. Agrees to raise issue with town officials.

VOTE:

- Richard Smith moves to approve the replacement of the first floor vinyl only (as applied, with Anderson 400 series) and to deny the replacement of the other 9 windows, which are historical and do not appear to be in irreparable condition.
- S. Belkin seconds
- Unanimous vote
- No abstention

OTHER BUSINESS

None.

R Smith made a motion to adjourn. S Belkin seconded. Unanimous vote.
