## **Report of the Executive Director**

The Executive Director reported that the waitlist has 17,984 applicants. Of that 12,723 are families, 2,482 are elderly and 2,779 are handicapped. The Authority has two units available, one senior handicapped at Doherty, and one family unit; a three bedroom. Also, there is a possibility of two more units and senior handicap becoming available by the end of the month. The Executive Director and maintenance staff have been working on the work order system, and clearing out a backlog of older work orders. We've extended the Wi-Fi reach for maintenance staff and a laptop to help out with execution, and clearing out the work orders. A new task for the maintenance staff is a preventative maintenance checklist for the month. This is to help with tasks that need to be done within a given month.
