

# Town of Swampscott Select Board Meeting Minutes

Wednesday, November 10, 2020 – 6:00 PM Virtual Meeting

## **PUBLIC COMMENT**

Erik Schneider spoke regarding Article 15, the Citizen's Petition. His intention is to ensure the community sees the need to commit funds to give the facilities department the ability to find solutions to needed maintenance and safety in the Clarke, Hadley, and Stanley Schools. He feels this Article helps address some inequities in the school system.

## PRESENTATION ON THE PRELIMINARY TAX RECAP

Assistant Town Administrator of Administration and Finance Ron Mendes provided a thorough presentation on the Tax Rate Recap.

Patriot Properties valued every property in town and provided a summary of the values. There has been a 3.8% increase in the value of single-family homes and the value of condominiums has increased 12.8%. Commercial property value has seen an increase of 8.9%,. These are based on values from January 1, 2020.

The Select Board the increase in the assessed value and the fact that it appears low. Town Administrator Fitzgerald will reach out to Patriot Properties to better understand the valuation and particularly why there is a disparity between single-family homes and condos. Asst. Town Administrator Mendes suspects that the high-end properties are not selling quickly, where as the

condos are seeing greater sales. Greenwood Ave. condominiums could also be contributing to the 12.8% increase in condo value.

Mr. Mendes showed the levy analysis from 2011-2020 and the excess levy capacity for 2021 and free cash balance. The Town Administrator proposed a \$1,5500,000 free cash transfer.

Mr. Mendes reviewed the 5 levers that the Town has at its disposal to manage tax policy: 1. Setting the Town Budget; 2. Estimating Local Receipts; 3. Transferring from Free Cash/Reserves; 4. Small Business/Residential Exemption; 5. Split Tax Rate.

Mr. Mendes reviewed options for splitting the tax rate between Commercial/Industrial Properties (CIP) and Residential Properties. The Town Administrator's recommendation is to make a 1.7 shift and increase the CIP rate from 7.14% to 12.14% and decrease residential from 92.85% to 87.86%. This would keep the single-family tax bill the same as last year, with a \$0 increase. Shifting by 1.75 would keep the single-family and condo rate the same, requiring a lesser transfer of free cash, but transfer more tax burden onto commercial properties.

Mr. Mendes reviewed the Small Commercial Exemption option which shifts tax burden from small properties that have an annual cumulative employment of less than 10 employees and property value of less than 1 million. If they meet this requirement, they receive a 10% reduction in tax bill, which is achieved by increasing taxes on commercial and industrial properties. Total exemptions for FY21 would be \$26,046. This exemption has been voted affirmatively two years in a row. Chairperson Spellios asked if we've seen any benefits or improvements made by businesses due to this money they are not spending on taxes (improvements in properties, for instance). He requested that the Office of Community and Economic Development reach out to businesses to determine if they have seen benefits of these savings.

Mr. Mendes also outlined a residential exemption option which shifts the tax burden from low value residential properties to non owner-occupied and higher-valued residential properties. He provided different options to show what combination of considerations would result in what tax bills, with the goal of potentially maintaining the same tax rate as FY21.

Chairperson Spellios asked that Mr. Mendes refer to median home values rather than average at the December 2<sup>nd</sup> official Tax Recap.

# Article 10 - Zoning Bylaw Amendment - Technical Amendments

## Article 12 - General Bylaw Amendment - Adoption of Noise Bylaw

Chairperson Spellios explained that the bylaw is not ready. Town Administrator Fitzgerald stated next steps are to build off of other bylaws and talk to Town Counsel about enforceability.

## Article 14 – General Bylaw Amendment – Marijuana Licensing

Bylaw language has been cleared up to consist of only one section limiting number of licenses.

## Article 15 – Proposed Capital Project – Repair our Elementary Schools

Peter explained that the Article has to go to the floor as it is written. It requires 3,000,000 to be added to the tax levy. The language cannot be changed to alter the funding mechanism (borrowing vs. tax-funded).

Terry Lorber spoke to describe Article 15.
