

Yesterday evening, Robert Corcoran (owner of 133 Puritan Road at the entrance Lincoln House Point) submit a copy of the application to MassHousing for site approval under Chapter 40B. This is the first step that's required when a developer intends to pursue a Chapter 40B housing development.

MassHousing is currently reviewing an application for Site Approval submitted by 133 Puritan Road Swampscott Development, LLC (the Applicant). The proposed development will consist of 16 homeownership units on approximately 1.06 acres of land located at 133 Puritan Road in Swampscott, MA.

The site approval process is offered to project sponsors who intend to apply for a comprehensive permit under Chapter 40B. MassHousing's review involves an evaluation of the site, the design concept, the financial feasibility of the proposal, and the appropriateness of the proposal in relation to local housing needs and strategies. As part of our review, we are soliciting comments from the local community and we would appreciate your input. You also may wish to include in your response, issues or concerns raised by other town boards, officials or other interested parties. Pursuant to the Massachusetts General Laws Chapter 40B regulations (760 CMR 56.00) your comments may include information regarding municipal actions previously taken to meet affordable housing needs such as inclusionary zoning, multifamily districts adopted under G.L. c.40A and overlay districts adopted under G.L. c.40R. Your comments will be considered as part of our review.

We have been informed by the Applicant that the Town has received a copy of the application and plans for 133 Puritan Road. Please inform us of any issues that have been raised or are anticipated in the Town's review of this application. We request that you submit your comments to this office within 30 days so we may process this application in a timely manner.

During the course of its review, MassHousing will conduct a site visit, which Local Boards, as defined in 760 CMR 56.02, may attend. The site visit for 133 Puritan Road has been tentatively scheduled for Tuesday, August 22<sup>nd</sup> at 10 a.m. Please notify me promptly if any representatives of your office or if other Local Boards plan to attend the scheduled site visit.

Please note that if and when an application is submitted for a comprehensive permit, assistance is available to the Swampscott Zoning Board of Appeals (ZBA) to review the permit application. The Massachusetts Housing Partnership's (MHP) *Ch. 40B Technical Assistance Program* administers grants to municipalities for up to \$15,000 to engage qualified third-party consultants to work with the town's ZBA in reviewing the Chapter 40B proposal. We can't thank you enough for granting us permission to host the Inaugural Boston Fox Trot 5K Run/Walk in your town. Thanks to your support, we've already raised over \$12K for Parkinson's Research and our goal has now jumped to \$30K.

We've gotten some requests from neighboring supporters, Bent Water Brewing Company, Ipswich Ale Brewery and Barefoot Wine & Bubbly to see if we may be able to get a 1 day liquor license for the event to offer our participants/spectators some post run/walk libations from 1pm – 3pm.



Dear Selectmen,



I am writing to request your approval for the 12th Annual fundraising 3.1 mi run/ 1.0 mi walk on behalf of our son, Kyle Butt. The run is called "Miles for Kyle". We are requesting that the run be held on Sunday, October 15th, 2017 starting at 10 o'clock in the morning at Beach Bluff Park at Preston Beach. I have detailed the routes of the run and walk respectively in the last paragraph for your review and approval. I am planning on having police be present at the race to ensure the safety of the runners and walkers, and would be grateful for any other recommendations you may have. We will also be providing refreshments and T-shirts for the participants after the race/walk.

As a matter of background, Kyle was diagnosed with Infantile Spasms at age 5 ½ months and was initially treated by pediatric neurologic specialists at MGH. This treatment regimen did not help stop the seizures entirely and his development was reaching a plateau. On May 17, 2007, Kyle underwent brain surgery at Cleveland Clinic Children's Hospital in Ohio to remove areas of the right side of his brain that were causing his seizures. Last year, our cause was able to raise and donate enough money to the Chelsea Hutchison Foundation to assist in the placement of two seizure alert dogs with children with Epilepsy and our goal is to double that this year.

The race route is as follows:

Run: Starting line at Preston Beach Park. Proceed down Atlantic Avenue Take left onto Puritan Road. Take left onto Winshaw Road and follow to its end. Take right onto Puritan Road. Take right onto Atlantic Ave and proceed to finish line at Preston Beach Park.

Walk: Walk down Atlantic Ave. Take left onto Blodgett Rd. to its end and return down Atlantic Ave.

Thank you for considering our request and I look forward to your reply.
