1. Public Comments: This portion at the beginning of the meeting is to hear from the general public on any issue regarding Traffic Safety & Parking that is not otherwise listed below on this agenda.

3. Review of recommendations from consultant on traffic and parking on Humphrey Street (Redington to Blaney Street Corridor; and review of the Cedar Hill/Greenwood Ave one-way traffic study and public comments.
4. Review of Complete Streets Report and any recommendations.
5. Traffic & Parking Regulatory Requests – items to be reviewed by the Committee in order to recommend action by the Town Administration or to provide recommendations to the Swampscott Select Board for regulatory changes (if needed).
 - a. Request from a resident of Franklin Ave. for Resident-only parking on Franklin Ave to address parking issues related to local businesses in the area.
 - b. Request from parent of Clark school student for a traffic study regarding the hazardous traffic pattern during morning drop-off and afternoon pick-up on the streets surrounding the school (Hamden St., Ellis Rd., Middlesex Ave.).
 - c. Request from resident of Burpee Rd. for a stop sign/speed board at the corner of Burpee and Buena Vista to reduce speeding, as well as a request for police officers to give tickets to speeders on Burpee Rd. rather than warnings.
 - d. Request from resident of Nason Rd. to put the electronic speed meter that was removed back up on the road.
 - e. Request from resident of Paradise Rd. to enhance pedestrian safety at the crosswalks by Paradise Rd.
 - f. Request from business owner on New Ocean St. to make more 2-hour parking spots on south side of Burrill St. from Boynton St., and overall enhancement of parking on Burrill St. and New Ocean St.
 - g. Request from resident of Shaw Rd. to make Shaw Rd. part of Resident-only parking zone.
 - h. Request from resident on Cherry St. to place additional signage or walk signal for the crosswalk located on Cherry St.

- i. Request from resident for implementation of street tags for crosswalks around Atlantic and Humphrey to ensure safety.
 - j. Request from resident for a handicap parking space in front of 225 Humphrey St.
 - k. Request from resident on Banks Rd. resident for a traffic study regarding the road of Banks Road to find options to minimize the speeding on the street.
