 - d. META Grant opportunity (Municipal Energy Technical Assistance) was due Nov 17, max \$15-\$25K - we did not apply per recommendation from Max - Applying for EVIP grant would be preferable

- e. Revisit Solarize campaign. Is there a list of preferred vendors we can recommend to the community? New England Solar (for Hot Water heaters), Boston Solar (for PV panels), and NE Ductless (for heat pumps)? Nexamp community solar. (Ryan any update?)
- f. Outreach Actions:

 - iii. Other: Engage local contractors to discuss their recommendations, Community learning efforts; Electrification tours (houses), EV days, have local vendors to come out and support events
- g. Community First Program update (According to Revise, we are "hitting it out of the park" with weatherizations performed. We just hired an Energy Advocate for Lynn.)

- i. The following actions are assigned to REC and REC champions:

Buildings & Energy

- 1.1.A Increase enrollment in Swampscott Community Power 100% New England Green through ongoing promotion and education. (rh,ms)
- 1.1.B Work with National Grid to prioritize repair of leaking gas pipes in town in accordance with the Massachusetts Gas System Enhancement Plan, ensure scheduling is coordinated with planned road paving, and report progress on a quarterly basis. (ms)
- 1.2.A Promote existing incentives to increase adoption of small-scale solar electricity, prioritizing low-income residents and landlords
- 1.2.B Consider mechanisms such as a bulk purchasing program to encourage purchase of solar panels and battery storage among residents, businesses, and municipal departments.
- 2.1.A Develop a targeted, multilingual campaign for weatherization and energy efficiency, prioritizing low-income residents, renters, and landlords. (de/dt)
- 2.2.A Adopt the Municipal Opt-in Specialized Energy Code. (rh)

Transportation

- 2.2.A Increase EV charging stations at public parking facilities (e.g., Philip's Park, Fisherman's Beach, Police Station, new elementary school) and on-street locations. (ms,de)
