 - c. A meeting occurred Jan 10th to discuss Specialized Energy code with a few town stakeholders. Potential to vote at an upcoming town meeting (Feb or May). Town Meeting approval would be needed to achieve "Climate Leader" status.

 - ii. Need to work on the next level of updates any volunteers to work on this?
 - iii. What other useful information can be posted, such as guidance on Solar or Heat Pumps
 - e. Grant opportunities
 - i. We did not receive MAPC grant which may have funded a Sustainability Manager.
 - ii. META Grant opportunity (Municipal Energy Technical Assistance) per recommendation from Max Applying for EVIP grant would be preferable
 - iii. EVIP grants for EV charging stations are available on a rolling basis. Green Communities also recommended we apply MassEVIP. Work with Max to get cost estimates/locations.
