NEW AND OLD BUSINESS:

Open Session

1. Vote to approve prior meeting minutes.
2. Other business as needed.
3. Vote to enter into and not return from Executive Session.

Executive Session

1. Executive Session – General Laws 30A, Section 21 (a) – Purpose (8) - To consider or interview applicants for employment or appointment by a preliminary screening committee if the chair declares that an open meeting will have a detrimental effect in obtaining qualified applicants; provided, however, that this clause shall not apply to any meeting, including meetings of a preliminary screening committee, to consider and interview applicants who have passed a prior preliminary screening – Director of Assessing Position.
2. Executive Session – Pursuant to G.L. c.30A, §21(a)(7) ("Purpose 7"), the Board will meet in executive session to discuss, comply with, and/or act under the authority of G.L. c.59, §60 and related privacy laws; votes may be taken.
3. Executive Session – Pursuant to G.L. c.30A, §21(a)(3) ("Purpose 3"), the Board will meet in executive session to discuss strategy with respect to litigation if an open meeting may have a detrimental effect on the litigating position of the public body and the chair so declares: Abatements; ATB appeals.
