## **Description of Addendum**

The Town of Swampscott hereby provides this addendum to its Invitation for Bid #2021-012. The purpose of this addendum is to:

- (1) Extend the Bid Deadline and Bid Opening to March 25, 2021 @ 2:00PM;
- (2) Provide a Revised Scope of Work to provide additional information further describing the parcels of land subject to this bid (Revised Scope of Work is attached to this Addendum AND *included in a Revised IFB* uploaded on the Town website at www.swampscottma.gov/bids).
- (3) to revise the language in Section 2.17 PAYMENT BOND to reflect the following language: 2.1.7 PAYMENT BOND

  The selected contractor shall be required to furnish a Payment Bond in the amount of fifty percent (50%) of the contract price, within ten days of the date of notification of the contract award. Bonds may be issued for a 12-month term with renewals for subsequent 12-month terms of the contract by continuation certificate; and
- (4) Provide a revised Bid form (revised form attached to this Addendum and *included in revised IFB*).

Proposals will be received at the Town of Swampscott, Office of the Town Administrator, 22 Monument Ave., Swampscott, MA 01907 on or before **2:00PM**, on Thursday March **25**, **2021** at which time the bids will be publicly opened.

Also, Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c.30A, §18, and the Governor's March 15, 2020 Order imposing strict limitation on the number of people that may gather in one place, the RFP Opening in connection with the above referenced procurements will be conducted via remote participation. Specific information and the general guidelines for remote participation by members of the public and/or parties with a right and/or requirement to attend this meeting can be found within this posting below. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings in real time, via technological means.

#### REVISED SCOPE OF WORK

#### **ATTACHMENT 1**

#### LAWN MAINTENANCE AND MOWING CONTRACT (3 YEAR CONTRACT)

- 1. Before the first mowing in the spring, all debris, leaves, paper, and trash that have accumulated over the winter shall be picked up and legally disposed of off the property. This shall include complete trash and litter clean-up of all fences, paved, lawn, and planting areas, within the limit of the work line. Picked up items shall be legally disposed of off the site by the Contractor.
- 2. Before all mowing, Contractor shall familiarize themselves with the location of all in ground irrigation heads to eliminate potential for damage. Any damage to irrigation heads caused by Contractor's operations shall be repaired immediately at Contractor's expense.
- 3. The Contractor shall submit a mowing schedule for the season for approval by the Director of Public Works. All mowing will be scheduled for Thursdays. In the event mowing is changed to another day of the week, the mowing schedule will revert back to Thursday of the following week. Avoid mowing when the grass is wet. The Contractor must notify the Director of Public Works directly in advance of any changes in the approved schedule.
- 4. Mowing and trimming shall be performed not less than once per week. At the time of cutting, keep mower blades adjusted for a finished cut height of between one and one-half and two  $(1 \frac{1}{2})$ " inches.
- 5. Areas around trees, shrub beds and other obstacles, and along fence lines at top of slopes shall be hand trimmed at the time of each mowing and neat lawn edges shall be maintained.
- 6. Mowing direction shall be varied with successive cuttings to encourage upright growth of shoots.
- 7. Locations are listed in Exhibit A and B
