# **COLA Hearing**

The Board voted unanimously on a motion made by Robert Powell and seconded by Kevin Breen to open the Public Hearing at 8:11am. A roll call vote was taken Driscoll "I", Behen "I", Powell "I" and Sarro "I".

After a brief discussion, the Board voted unanimously on a motion made by Robert Powell and seconded by Vice Chair Behen to approve a 3% COLA effective July 1, 2020 and to close the public hearing. A roll call vote was taken Driscoll "I", Behen "I", Breen "I", Powell "I" and Sarro "I".

# **Performance Report:**

DAHAB Consultant, Greg McNeillie met with the Board to review the 1st Quarter Performance Report of the System for the period ending 03/31/2020. As of March 31, 2019, the System's total portfolio account was valued at \$56,380300. Mr. McNeillie reviewed the report in detail. There was a discussion relative to cash flow in and out of the System. Mr. McNeillie explained that negative cash flow in certain quarters was normal for systems that receive their funding in one lump sum. The full report is on file in the office.

the Annual Town Meeting articles to financial only. It is anticipated there will be a Special Town Meeting in the fall.
