1. APPOINTMENT OF RICHARD SIMMONS AS INTERIM TOWN ASSESSOR:

TA FITZGERALD IS PLEASED TO BRING RICHARD SIMMONS BEFORE THE BOARD. RICHARD IS A RESIDENT OF SWAMPSCOTT AND HAS BEEN A MEMBER OF A BOARD OF ASSESSORS, CHAIRED THE ESSEX COUNTY ASSESSORS AND HAS OFFERED TO HELP IN AN INTERIM CAPACITY. HIS COMMITMENT TO PUBLIC LIFE & PUBLIC SERVICE IS EXEMPLARY. WE'LL BE LOOKING DILIGENTLY TO FILL THIS POSITION PERMANENTLY. MR. SIMMONS STATED THAT HE IS HAPPY TO HELP THE TOWN OUT AND HAS BEEN ACTIVE IN EVERY COMMUNITY HE HAS LIVED IN. HE HAS WORKED AS AN ASSESSOR, IS QUALIFIED AS AN APPRAISER & IS A REAL ESTATE APPRAISER. WHILE HAPPILY RETIRED HE WANTS TO HELP THE TOWN. MR. DUFFY COMMENTED THAT HE APPRECIATES MR. SIMMONS' WILLINGNESS TO SERVE THE TOWN IN MULTIPLE CAPACITIES AND THAT IT IS GOOD TO HAVE SOMEONE WITH SUCH EXPERTISE TO FILL IN.

TA FITZGERALD STATED THAT HE WILL MAKE SURE THAT IS DONE, THAT WE WILL ADD THIS REQUIREMENT TO APPLICATIONS GOING FORWARD AND THAT HE IS LOOKING TO PURCHASE RECYCLING BINS TO BE PLACED ON PUBLIC STREETS.
