A meeting of the Contributory Retirement Board was held via Zoom conference call on Tuesday, September 22, 2020.

The meeting was called to order by the Vice Chairman at 8:10am.

FY' 21 Appropriation Housing Authority

Old Business

COLA Article for Fall Town Meeting

The Board agreed to again place an article in the fall Town Meeting warrant relative to increasing the COLA base from 13k to 14k. The Article was originally slated for the May 2020 Town Meeting but due to COVID many warrant articles were removed in anticipation of a fall Town Meeting. The Board will prepare a handout for all Town Meeting members as well.

New Business

Overpayment of Beneficiary Allowance – F. Brown

After a review of Mr. Browns records, it was determined that he received an overpayment in the amount of \$1,956.28 for beneficiary allowance. Mr. Brown had requested that he be allowed to payback the monies due in installments of \$200 per month. The Board voted unanimously on a motion made by Kevin Breen and seconded by Robert Powell to allow Mr. Brown to repay the System \$200 per month (10 payments).

A roll call vote was taken Behen "I", Breen "I", Powell "I" and Sarro "I".

Pension Benefits Received After Death

The Administrator informed the Board that the two retirees who passed in August received their full allotment of pension since notice of death was discovered after payment was made. The Board will have the administrator contact the estate of both deceased members and request the overpayment of funds be returned to the System.

Discussion on ADR Retirements prior to 1994

ADR Retirements prior to 1994 were not provided an opportunity to select an option C benefit. There were 3 deaths in the past several months who were all retired under ADR retirements prior to 1994. The 3 surviving spouses are all eligible for a section 101 benefit which provides an annual benefit of 12k. The administrator will reach out to each spouse to see if they would like to apply for a section 9 death benefit as well. Section 9 death benefits may apply if it is determined there is a causal relationship between the cause of death and the disability that the member retired from and with approval from PERAC.
