### VI. Report of the Executive Director

The Executive Director gave a report about the waiting list and the number of vacancies.

She also presented the initiative Whole Foods Supermarket has taken to partnership with the SHA and food donation for our residents.

#### VII. New Business

Jenna presented the budgets for fiscal 2022 that included the 400, 689, and MRVP programs. She also included the administrative salary. She projected the elderly and family programs to be at a 40% reserve, which DHCD requires the Housing Authority to be a 35%.

Commissioner Tara Cassidy-Driscoll called a motion to approve the budgets presented, seconded Catherine Esteverena.

Chief Archer from the Fire Department asked if the board had any questions regarding the Elm Place Project and Tara asked if there was a particular issue that people might be concerned about. Chief Archer said there have been concerns and they will be addressed at the next Zoning Board Meeting.

Mr. Grishman recommended that the meetings be recorded and posted on the Town website to bring additional engagement and information. Catherine said that the office is entirely accessible, and meetings are recorded, and are very convenient for the tenants as they can easily walk to the meetings. She also stated that although the Town says the selection process for the new board member was unfair, it was the Tenant's Association that appointed the board member. Mr. Grishman brought up the concern about the ramp behind the office not being ADA compliant and it is against the Mass general law to have a public meeting a building that is not ADA compliant, which is why the Select Board is offering the High School to be used for meetings. Chair Callahan that as of right now, it is speculation on whether the ramp is wide enough or not, and it has never been an issue with the state government or the Town.

Director Chez corrected a comment made by a select board member at a meeting; the member said that the Housing Authority meetings are done in secret. As the acting secretary of the SHA Board, she sends the agenda on Thursdays via email to Susan Duplin Swampscott Town Clerk and to Brittney Jones, Administrative Assistant to the Town Clerk prior to the Tuesday's meetings and a confirmation email is received. Executive Director, Chez said that the meetings are public and are posted on the Town's website just like the other boards in Town.

#### VIII. Old Business

David Grishman talked about the Select Board having a split vote on the SHA Board vacant seat; there was no vote brought to the floor. The Select Board will not take any action and will wait until the April's election.

Commissioner Esteverena made a comment about the SHA board having to postpone February's regular because there was not a quorum due to one of the board members being ill and the vacant seat not being filled on time.

# IX. Adjournment

Chair Callahan called for an adjournment.

Commissioner Cassidy-Driscoll motioned to adjourn. Second: Commissioner Esteverena.
