Commissioner Dreeben began the meeting by congratulating Director Chez on being able to apply and receive a Resident Service Coordinator Grant for the Swampscott Housing Authority. Questions were asked about the grant itself and what it constitutes; Director Chez provided all the information and mentioned that there are not any specific details yet, but she will work on it.

Commissioner Dreeben also mentioned the new application for available funds for redevelopment and rehabilitation for public housing using innovative methods called The Public Housing Innovations Notice of Funding Availability (Innovations II NOFA). Given the three options for possible redevelopment, including but not limited to: mixed income, alternate funding sources with new management including affordable housing, or conversion to Federal Public Housing, the Housing Authority has decided to preserve all low-income sites. The goal is to develop and promote cost effective public housing and

preserving it for the long term. Chair Callahan called a motion to approve this application, and everyone agreed.

While some members were concerned about the extensive process, Director Chez informed them that she will be reaching out to Avalon the DHCD Project Manager so that he can guide with the process. Commissioner Esteverena asked about the tenant representative expected to be selected by the Town Select Board, as per the new State Law a Tenant of the Housing Authority must be assigned to fill the vacant sit on the SHA Board.

Director Chez informed everyone that she emailed Allie regarding this matter and had not heard anything. A discussion opened about the challenges in the elderly/disabled sites, Commissioner Dreeben asked about the community rooms and Director Chez informed her that there are two community rooms, one located at Doherty Circle and the second one at Duncan Terrace. Most tenants use the laundry room adjacent to the community room, which makes it very inconvenient. Director Chez raised concern about relocating about 50 residents and adding additional parking spots can be an issue if we are looking to redevelop in the future.

The Market Rent subject was brought up and most members disagreed about having mixed income and such high rates, they would like to keep it all low-income and elderly ONLY.

Commissioner Dreeben raised a concern about the community room being too small and the units not being handicapped accessible. Everyone hopes to have universal design so that every resident has access to their units and common areas. Marzie Galazka, Director of Community Development for the Town of Swampscott agreed to report back to the board members with a brief rough draft of the NOFA application.

Towards the end of the meeting, Juneteenth was brought up, Director Chez talked about it being a very important holiday regarding racial freedom and board members proceeded to approve it as an official state holiday.
