#### PETITION 22-02

### SWAMPSCOTT HOUSING AUTHORITY

Petition by SWAMPSCOTT HOUSING AUTHORITY c/o IRMA CHEZ. Requests Sign Special Permit for installation of one entrance sign at each of three properties. Property addresses 29-31 CHERRY ST (Parcel ID: 6-187), 6 DUNCAN TER (Parcel ID: 3-31), and 22 BURRILL ST (Parcel ID: 6-118B)

Richard Callahan of the Swampscott Housing Authority was present for hearing.

The Board had no questions; the item was opened for public comment.

Diana Weinstein, abutter of the Duncan Terrace property, asked for clarification of where sign would go.

PETITION 22-03

Petition by MICHAEL JONCYZK. Requests Dimensional Special Permit for construction of front porch. (Parcel ID: 3-31)

Mr. Joncyzk was present for the hearing. He provided before the Board a property survey and a signed letter of support from abutting neighbors on either side.
