Purpose:

This Compliance Report is provided pursuant to Paragraph 33 of the subject Consent Decree between the United States of America and the Town of Swampscott, MA. This report covers the reporting period noted below:

Reporting Period: February 1, 2017 through July 31, 2017

Through this reporting period, the primary activity was the construction of Phase 1A sewer rehabilitation within the Stacey's Brook area. Bids for construction were opened on January 31, 2017. The following report summarizes construction progress during the Reporting Period.

Bid Opening and Award Recommendation

A total of eleven (11) bids were received for the Phase 1A construction contract during bid opening on 1/31/2017. The apparent responsive low bidder was DeFelice Corporation (Dracut, MA) with a total bid amount of \$923,250.

Kleinfelder reviewed bidder references and made a recommendation to the Town to award the construction contract to DeFelice. As of the date of this report, the work under this contract is approximately 90% complete.

Construction Summary

The scope of work of Phase 1A consists of the removal and replacement of approximately 5,970 linear feet of 6" vitrified clay pipe with 8" PVC pipe, the repair of 25 type 1 underdrain manholes, the installation of 3 precast manholes and the removal and replacement of 1 existing manhole



with a precast manhole on Norfolk Avenue. The base bid contract price is \$823,250 with an additional unforeseen conditions allowance of \$100,000, which is paid to the contractor in the form of change orders for extra work.

As of 7/31/17, DeFelice Corporation had installed 5,230 linear feet of 8" PVC sewer pipe and 1 precast manhole. Unforeseen conditions encountered by the Contractor included the removal of approximately 491 cubic yards of ledge, repair of a mismarked water service and a drain lateral and repair of a home owner's sewer service lateral.

The work remaining to complete includes the installation of 740 linear feet 8" PVC pipe, 2 precast manholes, and the repair of 25 type 1 underdrain manholes.

The Contractor's request for payment #4, dated 7/31/17 included total construction costs completed and stored of \$717,987.65, which included two change orders for the unforeseen conditions listed previously.

Phase 1B Bidding and Construction

The next construction phase (Phase 1B) shall generally consist of cured-in-place pipelining (CIPP) of the main line sewers within the Stacey's Brook area. Approximately 32,100 linear feet of sewer ranging from 8 inches to 12 inches diameter will be included. A tabular summary of construction quantities and costs was included in Kleinfelder's Memorandum to the EPA, dated December 28, 2016.

This phase of construction is expected to be publically bid in the Fall of 2018 and construction expected to start thereafter.
